Spring 2022 Conference

Speakers confirmed since last meeting:

Steve Lehto – vlogger (video blogger)

Key Note: Linda LeGarde – University of Minnesota Faculty Member

Venue Possibilities: (Brandy)

Option One:

Masonic whole floor for \$1,100 (discounted from \$2,200)

Plus \$125 per room for AV set up fee if needed

Need event insurance

Can bring in food

Option Two:

Library \$150 for big room downstairs and the breakout room

Will accommodate 80 or less. We only had one year with more than 80

No event insurance needed

They have at least one AV set up

Will look into food set up. Possibly use the ACRC additional space for lunch???

Can't reserve until six months out (may be able to sooner)

Action Step: Brandy will find out if we can reserve library early

Peter White Library was selected on the basis of cost and unknown turnout expected

Membership Report: Brandy

Ten new members joined for a current total of 99

About 40% of members renew in person at the conference in June

Renewal deadline is Jan 31 with a month grace period

There was a discussion about changing the membership fee structure

Action Step: Brandy will send out the membership fee options discussed (below) and we will vote in the next board meeting to determine the fee structure.

Membership Fee Options:

Institute a late fee of \$10 for memberships purchased after February

Institute a reduced fee beginning July 1

Allow free membership for those joining/renewing October or later in the year

Charge full price all year. Give a UP reader to those joining/renewing after October 1

Offer multi-year options. This would require placing funds in escrow.

Offer a three-year membership for \$100—a \$20 savings

Offer a three-year membership for \$120 (single or business/family at this price)

Video Recordings: Brandy

All videos are up to date on the Youtube channel and are organized into three categories:

1.UP notable books, 2. Online conferences, 3. Bonus materials (book trailers, interviews)

Usually UP notable books are up within a week after the event

Action Step: Victor will ask Evelyn at the Crystal Falls Library to promote the Youtube channel and will check to make sure she has the right links

UP Notable Book Club: Mikel

Mikel is working on the list of books with currently 8 choices

Will finalize in late December

One or two classic U.P. book will be added each year to honor much beloved works written ten or more years ago.

Idea: run a week after Michigan notable (around January 10)

UP Reader: Debbie

There have been 35 submissions from 22 authors for a total of 47,000 words to date There will be four Dandelion stories added

Many submissions are expected before the deadline of Nov. 15--not all will be accepted

Audio Books: Victor

The last of the five are out there

24 copies of the UP Reader, volume 4 audio book sold in October

All audio books with the UP Reader, Great Lakes Talking Books, and Mikul's points north Brandy will finish recording the UP Reader one month after it is finalized
